This retains the taste and quality" summarises Roland Schultz, Director Marketing Packaging at ALBIS PLASTIC.

SHELFPLUS[®] O_2 is available on various base materials such as PP, PE or also EVA. A PA-based type is also in progress. All types can be used in both flexible or firm plastic packaging.
