The product is distinguished by its excellent surface quality and flexibility combined with its outstanding processing properties. As a representative of the Purell product family, Purell PE 2220D, amongst others, also satisfies the respective requirements of the European Pharmacopoeia (EP 3.1.4) and moreover comes with the typical service features of all Purell products, e.g. a commitment to formulation consistency.

The high-density polyethylene Purell ACP 5531B, which is specifically used in extrusion blow-moulding applications, supplements the product portfolio for industrial packaging in the pharmaceutical field, for instance, when used for dialysis applications or packaging of pharmaceutical ingredients on an industrial scale. In addition to its high impact resistance, the product also displays an excellent combination of stress crack resistance and stiffness. Purell ACP 5531B also has the service characteristics so typical of Purell. One example of this is a change management system for product modifications that is designed to meet the specific needs of the pharmaceutical industry.
