e. The listing applies only to products identical to those qualified. DLA Aviation-VEB must be advised in advance of any intended change to the product, changed in manufacturing location, Management officials or to the process(es). Failure to provide the required notification of any change in design, material or construction is cause for removal from the listing regardless of the extent of the change.

f. Firan Technology Group must comply with the requirement for retention of qualification every 2 years to retain the listing. Non-compliance shall be sufficient cause for removal from the listing.
