# **NOTE**

When purchased, the SpeedMaster<sup>™</sup> has four AA batteries pre-installed with a pull tab to prevent battery discharge. To activate the batteries, remove the pull tab from the battery tray.

The battery tray is located on the back of the unit. Remove the two screws holding the battery cover and pull the tab.

# **PRODUCT OVERVIEW**

The *Speed*Master<sup>™</sup> with Pulse Pilot provides independent, real time, and complete verification of an entire speed monitoring system to ensure that alarms and shutdowns are working as expected.

The *Speed*Master<sup>™</sup> operates in two modes. Input mode is used to measure the pulse rate at normal speed. Output mode will allow the user to input pulses to the sensor for testing purposes.

The Pulse Pilot fits in the gap between the sensor and cover on the Whirligig® (Image A). The Pulse Pilot will have no effect on the operation of the speed switch until it is connected to the *Speed*Master™ and set to output mode.



# **⚠** DANGER


When using the 4B Whirligig speed monitoring accessory the Pulse Pilot can generally be hand held even when the monitored shaft is rotating. However all applications are different and great care should be taken with regard to personal safety.

If a target system supplied by third parties is being used, the Pulse Pilot must <u>not</u> be hand held. The shaft should be stopped and locked out. The Pulse Pilot should then be attached firmly but temporarily (non-metallic industrial adhesive tape may be used). Guards should be reattached and then the system can be restarted.

# **SPECIFICATIONS**

Supply -	4 AA alkaline batteries (included - see notice on page 6) - 6 VDC
Control -	Push button
Input Mode Indication -	Red LED
Output Mode Indication -	Green LED
Display -	Yellow OLED (shaft speed / pluses per minute - PPM)
Power On -	Plug in Pulse Pilot (top of unit) and press power button
Power Off -	Unit powers off automatically if no buttons are pressed for 5 minutes. Unit can be turned off manually by pressing the power button.

# **DIMENSIONS**



## **NOTE**

Underspeed testing should only be performed when the machine is running at normal operating speed with no material present, and the belt is NOT slipping.

# **TESTER OPERATION**

- **Step 1.** Plug the Pulse Pilot into the top of the *Speed*Master™ and press the power button, the OLED display will illuminate.
- Step 2. Place the Pulse Pilot between the speed sensor and target (Image A). The *Speed*Master<sup>™</sup> is now in input mode and the input pulse light will flash each time a target is detected. The display will show speed in pulses per minute (PPM). The Whirligig® can have 1, 2, 4, or 8 pulses resulting in a measured speed of 1, 2, 4, or 8 times the shaft's rpm, respectively.
- **Step 3.** Press the "Calibrate" button, this will set the *Speed*Master™ to the measured shaft speed.
- **Step 4.** Press the "Mode" button, the output light will flash and the calibrated pulse rate will be fed to the sensor.

At this point, the input speed can be artificially raised or lowered by 1% each time the up or down buttons are pressed. By pressing and holding down the buttons, the input speed will be artificially raised or lowered continuously by 2% increments. Pressing the "PPM / %" display button will toggle between speed or percentage of calibrated speed.


The system should alarm/shut down when the underspeed trip point is reached.

# **MARNING**

If the system does not immediately shutdown as expected or alarm as required, then remove the machine from service until the problem has been diagnosed and corrected.

# TROUBLESHOOTING GUIDE

FAULT	REMEDY
OLED Display Reads "Connect Sensor" or "Connect Adaptor"	<ol> <li>Connect Pulse Pilot to the <i>Speed</i>Master.</li> <li>Ensure Pulse Pilot does not have a loose connection to the <i>Speed</i>Master.</li> </ol>
OLED Display not Functioning	<ol> <li>Replace batteries.</li> <li>If using for the first time, remove protective pull tab from batteries.</li> </ol>
Sensor not Responding as Expected to Testing	<ol> <li>Make sure the Pulse Pilot is securely inserted between the sensor and the Whirligig (See Image A).</li> <li>If equipment shuts down prematurely, ensure equipment is functioning correctly. For example: on a bucket elevator, check for belt slippage.</li> <li>If equipment has a delay or does not shut down, check sensor calibration. If sensor is still not responding as expected, contact 4B.</li> </ol>
