### This change affects Innovasic Part Number IA8X44-PLC44I-P03 only.

#### **Description of Change:**

- 1. The assembly/test supplier for the 44-pin PLCC has changed in order to ensure long term source of supply. Wafer fabrication remains unchanged.
- 2. Dashes have been removed from Innovasic's part numbering and the revision number has been reduced to one digit. Thus, IA8X44-PLC44I-P03 becomes IA8X44PLC44I3.

## **Impact of Change to the Customer:**

The new part will meet the same form, fit, and function parameters as the current part. Quality and reliability will not be affected based on the past performance of Innovasic's alternate assembly/test suppliers.
