P25-CAB-CAI_TEST_REQ – March 2010, Section 2.1.1.2 – Project 25 Phase 1 Common Air Interface Trunked Subscriber Unit Performance, DTR: TIMCO081016 IC-F9011T and TIMCO081016 IC-F9021T. Passed with the exception of simulcast portion of test cases 2.1.4, 2.1.5, 2.1.6, and 2.1.7 as the complying product does not support this feature. Passed with the exception of test case 2.3.1, where the device failed on low power mode only.
