With its takeover of the Danish intralogistics company, the Group is pushing ahead with the internationalization of its Business Area Logistics Systems.**

Qubiqa Logistics, based in Arden in northern Denmark, is a leading provider of depalletizing solutions. With around 90 employees the company mainly services customers from the food and beverage industry as well as the grocery sector. With its so-called Layer Picker® Qubiqa Logistics has the globally leading product in the layer depalletizing sector.
