What is exactly defined by PEP ecopassport® program?

Rules to make a product environmental profile:

- by measuring its impact on air, water, soil and natural resources: 11 indicators
- During the whole product life cycle, from its manufacturing to the end of life, through distribution, installation and use.

How does a PEP ecopassport® look like?
