It combines OHB-System's competences in the field of space aviation with those of the Telematics division of OHB-Teledata under one common roof and, by bundling the knowhow developed by OHB Technology with more than 20 years' experience in high-technology development, the organization is assured of an outstanding position in Europe.

Space Technology + Security business unit

The business field Space Technology + Security is sub-divided into the three key areas of small satellites, manned space flight and technologies for security and reconnaissance. OHB-System specializes in the development, construction, launch and operation of small satellites for scientific purposes, communications and observation of the earth. The field of manned space travel comprises the structure and scientific equipment of the International Space Station ISS. Again, the entire spectrum is covered from development, construction and training all the way to transportation. In addition, the growing market of technologies for security and reconnaissance is already being served quite successfully today. Germany's first satellite reconnaissance system is in the process of being engineered by OHB-System AG.

Telematics business unit

In the field of telematics, comprehensive solutions are being developed for the efficient organization and control of commercial transportation. Worldwide communication, data transfer and data processing are on offer under a single roof. The key focus is on such fields as transport logistics, consignment tracking, construction material logistics as well as the transportation of hazardous goods and refrigerated products. It develops and markets end-to-end solutions for efficient fleet and freight management using

(Internet-based) position, vehicle and container data.

Moreover, in this field of activity security applications are being developed for public authorities and organizations with security functions. Other key points of focus in telematics are GIS (Geographic Information Systems) as well as commercial, Web-based database solutions.

OHB Technology AG offers worldwide satellite services via its holding in the U.S. operator of the global satellite system ORBCOMM. OHB is in a position of being able to operate and market these satellite services in Europe on an exclusive basis.
