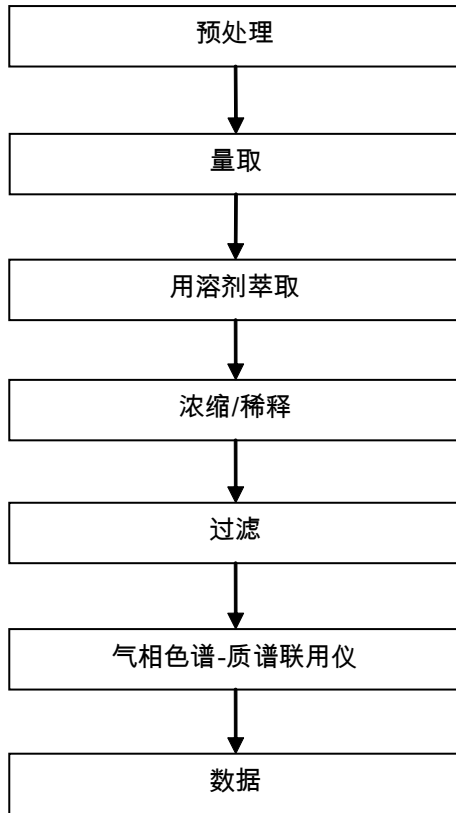

HBCDD 测试流程图

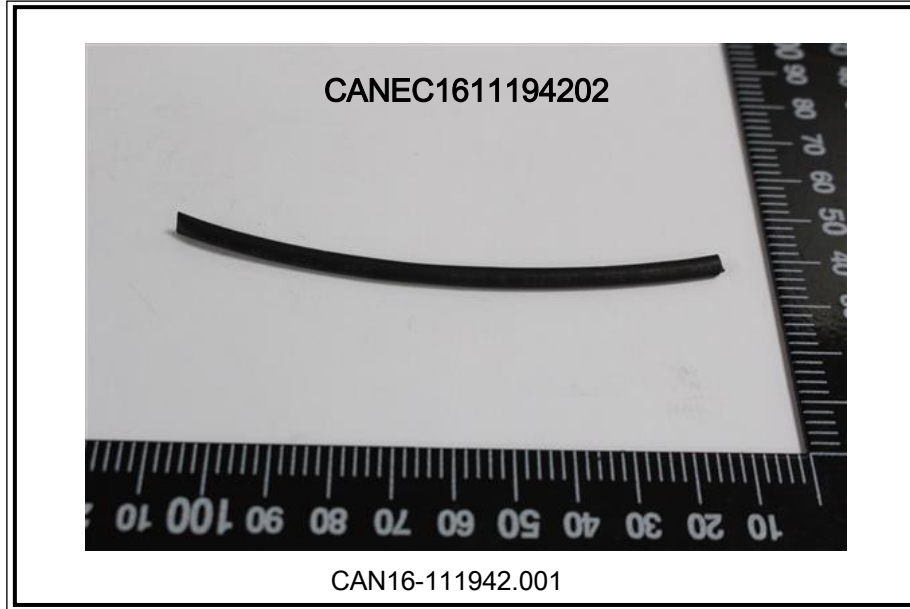
