

SELLER'S ASSURANCE OF REQUIRED INSURANCE COVERAGE SA-004 (08/11)

Refs: Raytheon General Terms and Conditions of Purchase TC-001

In support of the Purchase Order in which this SA-004 is incorporated, Seller acknowledges and agrees that it is obligated to maintain insurance coverage as set out below (the "Insurance"), and that it shall furnish Raytheon Company ("Raytheon") with certificates of insurance evidencing the Insurance required herein. In the event that Seller and/or any person or entity retained by, through or under Seller fails to maintain the required insurance, Raytheon may secure insurance to adequately protect its interests and Seller shall be fully responsible for the cost of such coverage. Additionally, Seller acknowledges and agrees that the Insurance shall contain a waiver of subrogation in favor of Raytheon and any of its affiliates, subsidiaries or related companies. Seller shall provide Raytheon with thirty (30) days written notice in the event of a material change to any of the required coverage including but not limited to the cancellation or non-renewal of any policy. The Insurance shall be primary as to any other insurance maintained by Raytheon and include a severability of interest clause. This SA-004 applies in addition to and not in place of the requirements in TC-001.
