


Figure 1. Representative Schematic Diagram (1/2 of Circuit Shown)






Figure 2. Burst Noise vs. Source Resistance




Figure 3. RMS Noise vs. Source Resistance




Figure 4. Output Noise vs. Source Resistance





Figure 5. Spectral Noise Density

Figure 6. Burst Noise Test Circuit

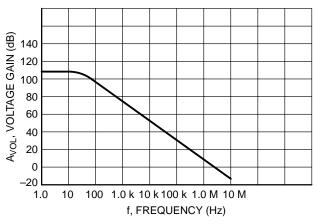


Figure 7. Open Loop Frequency Response




Figure 8. Phase Margin versus Frequency




Figure 9. Positive Output Voltage Swing versus Load Resistance




Figure 10. Negative Output Voltage Swing versus Load Resistance




Figure 11. Power Bandwidth (Large Signal Swing versus Frequency)

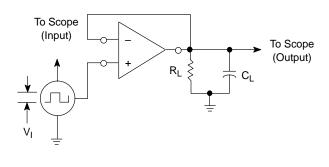



Figure 12. Transient Response Test Circuit
