




## Test Circuit 1: I<sub>OPH</sub>




Test Circuit 2: I<sub>OPL</sub>




Test Circuit 3: V<sub>OH</sub>




Test Circuit 4: V<sub>OL</sub>



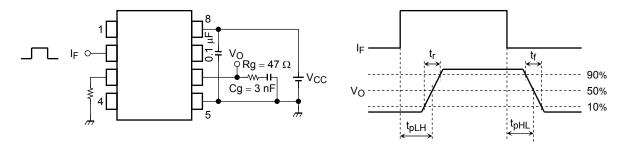
**Test Circuit 5: Icch** 




**Test Circuit 6: IccL**
