


#### TEST CIRCUIT 1: VOL Test Circuit




# TEST CIRCUIT 3: ICCL Test Circuit




# TEST CIRCUIT 5: IOSL Test Circuit




# **TEST CIRCUIT 2: VOH Test Circuit**




# TEST CIRCUIT 4: ICCH Test Circuit




# TEST CIRCUIT 6: IOSH Test Circuit




# TEST CIRCUIT 7: Switching Time Test Circuit




Figure 1 Device Orientation




Figure 2 Tape Forms




Figure 3 Reel Form







### (1) Precautions for Soldering

- 1) When Using Soldering Reflow
  - An example of a temperature profile when Sn-Pb eutectic solder is used:



• An example of a temperature profile when lead(Pb)-free solder is used:



- Reflow soldering must be performed once or twice.
- The mounting should be completed with the interval from the first to the last mountings being 2 weeks.

2) When using soldering Flow (Applicable to both eutectic solder and Lead(Pb)-Free solder)

- Apply preheating of 150deg.C for 60 to 120 seconds.
- Mounting condition of 260deg.C or less within 10 seconds is recommended.
- Flow soldering must be performed once

3) When using soldering Iron (Applicable to both eutectic solder and Lead(Pb)-Free solder)

- Complete soldering within 10 seconds for lead temperature not exceeding 260 deg.C or within 3 seconds not exceeding 350 deg.C.
- Heating by soldering iron must be only once per 1 lead
