


Fig 1. Diode capacitance as a function of reverse voltage; typical values.




Fig 2. Reverse current as a function of junction temperature; maximum values.




Fig 3. Diode capacitance temperature coefficient as a function of reverse voltage; typical values.

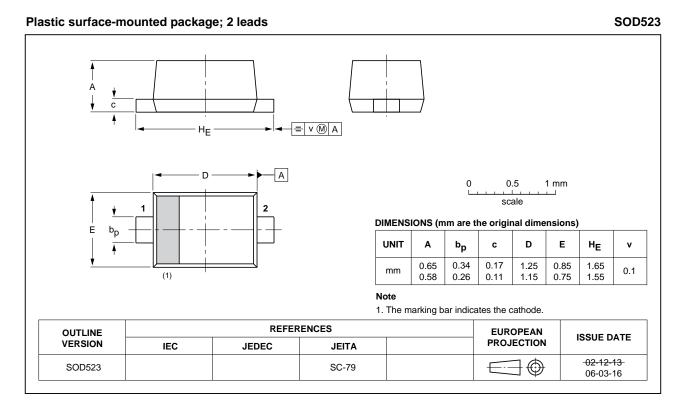


Fig 4. Package outline SOD523 (SC-79)
