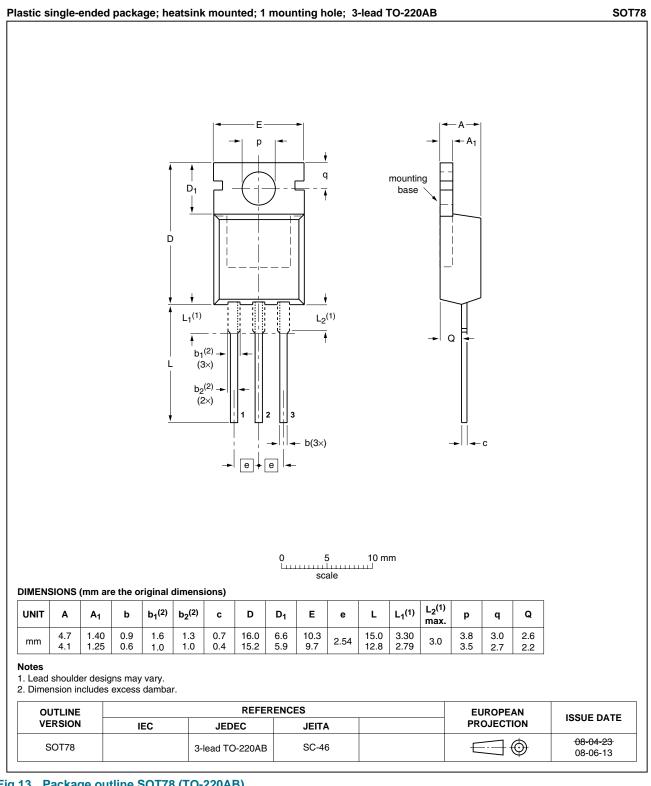


Fig 13. Package outline SOT78 (TO-220AB)
