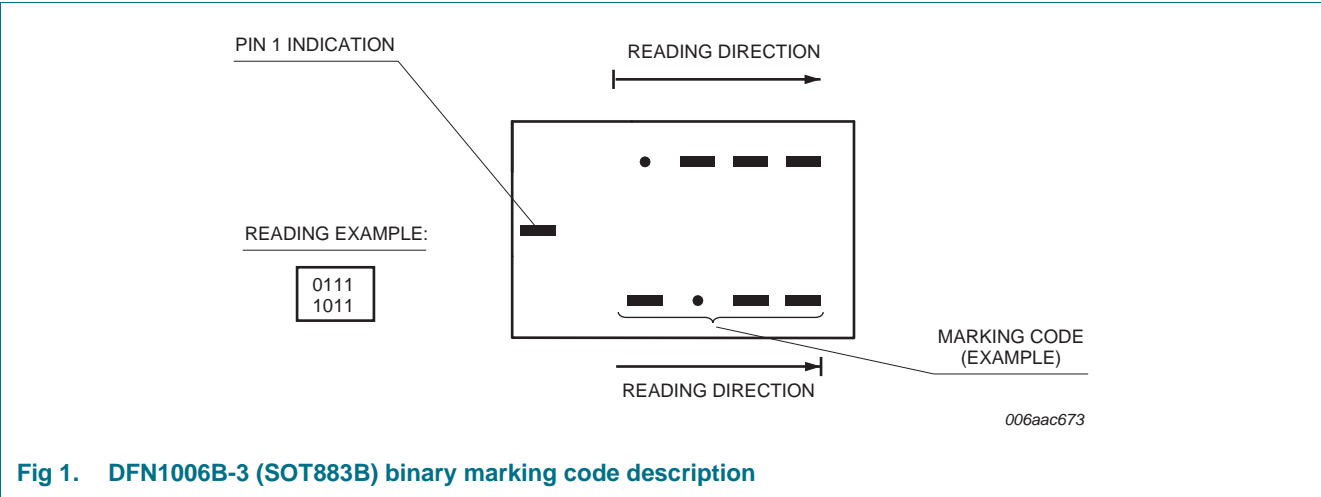

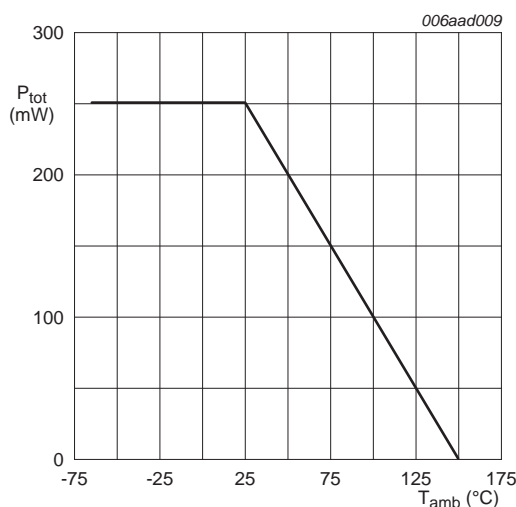

FR4 PCB, standard footprint

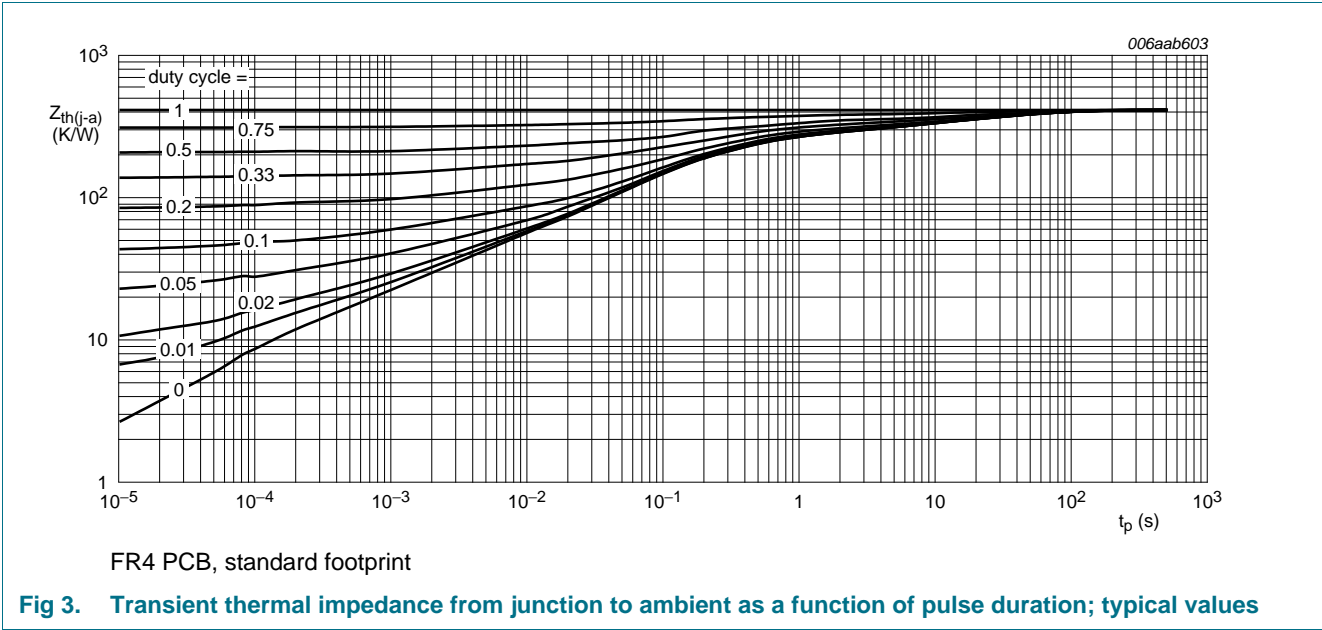
Fig 2. Power derating curve for DFN1006B-3 (SOT883B)

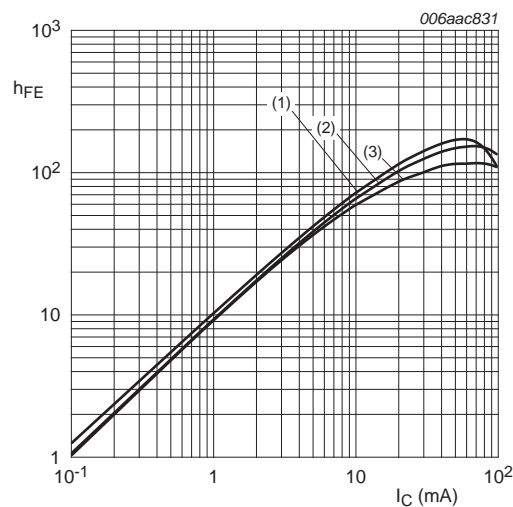

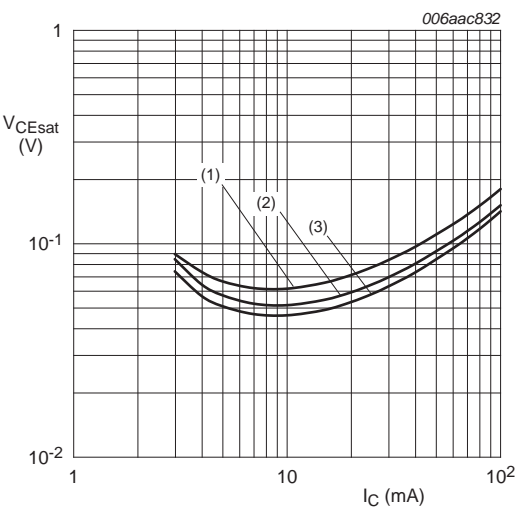

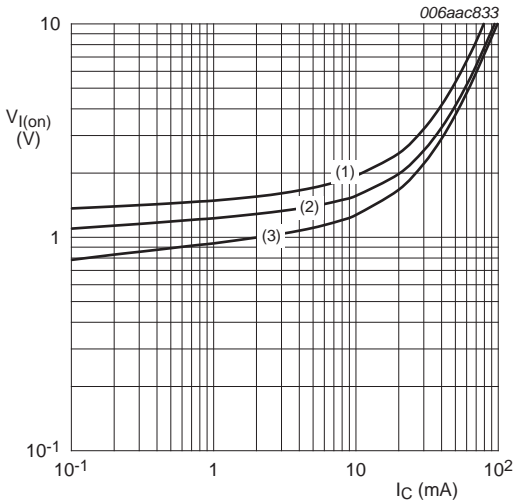

Fig 4. DC current gain as a function of collector current; typical values



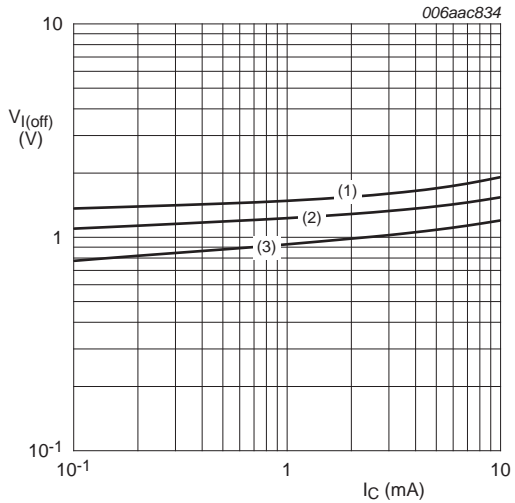

Fig 5. Collector-emitter saturation voltage as a function of collector current; typical values



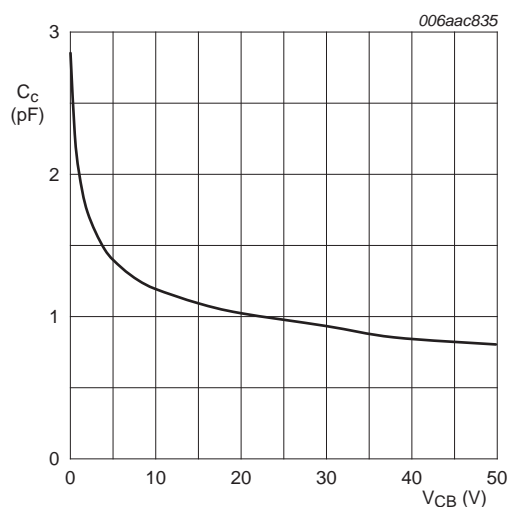

Fig 6. On-state input voltage as a function of collector current; typical values



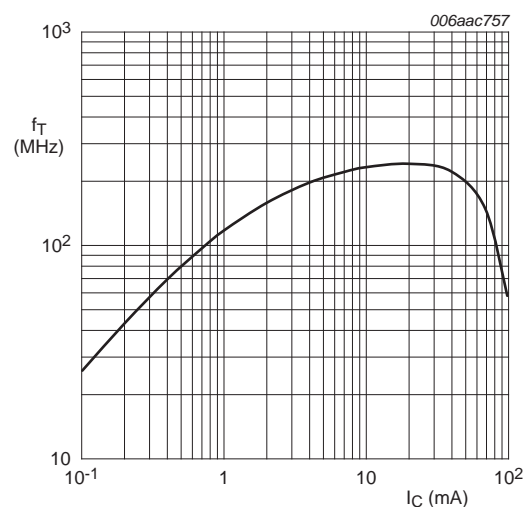

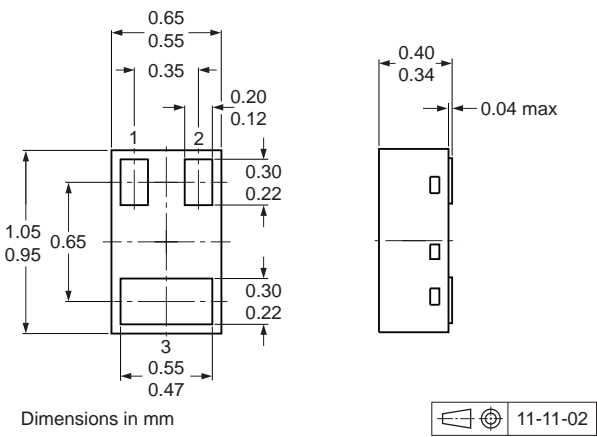


Fig 10. Package outline SOT883B (DFN1006B-3)

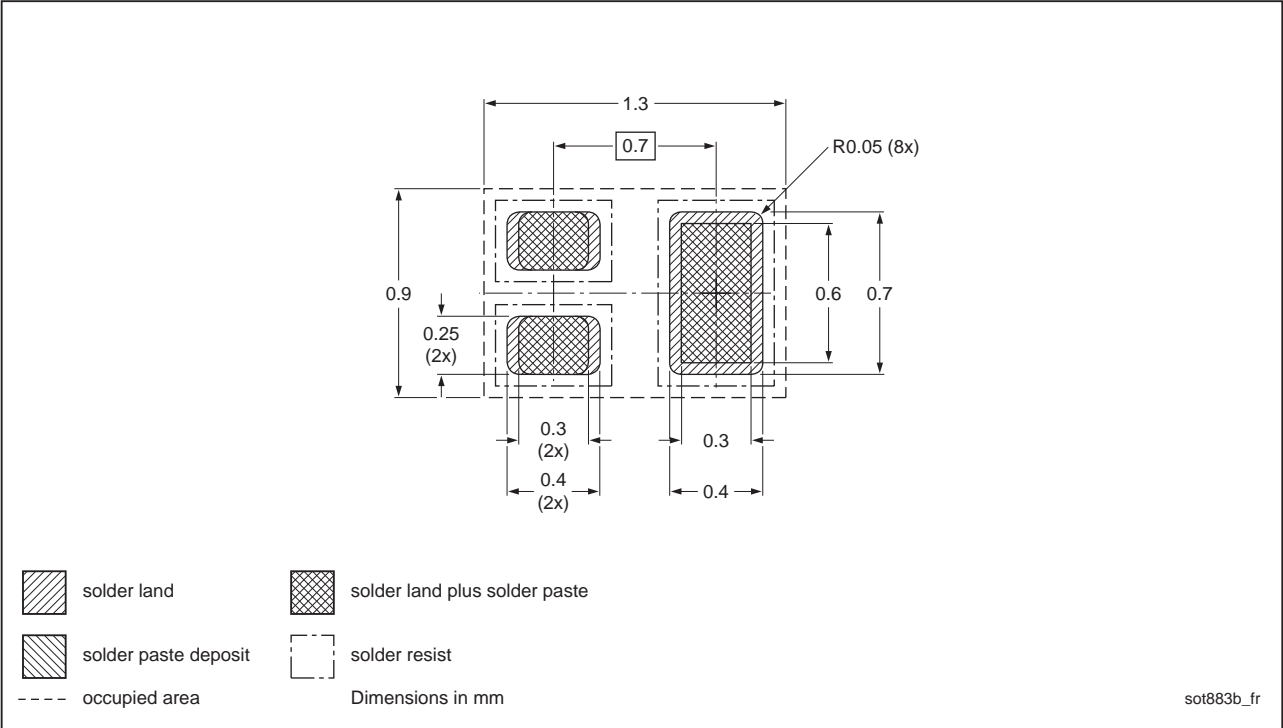


Fig 11. Reflow soldering footprint for SOT883B (DFN1006B-3)
