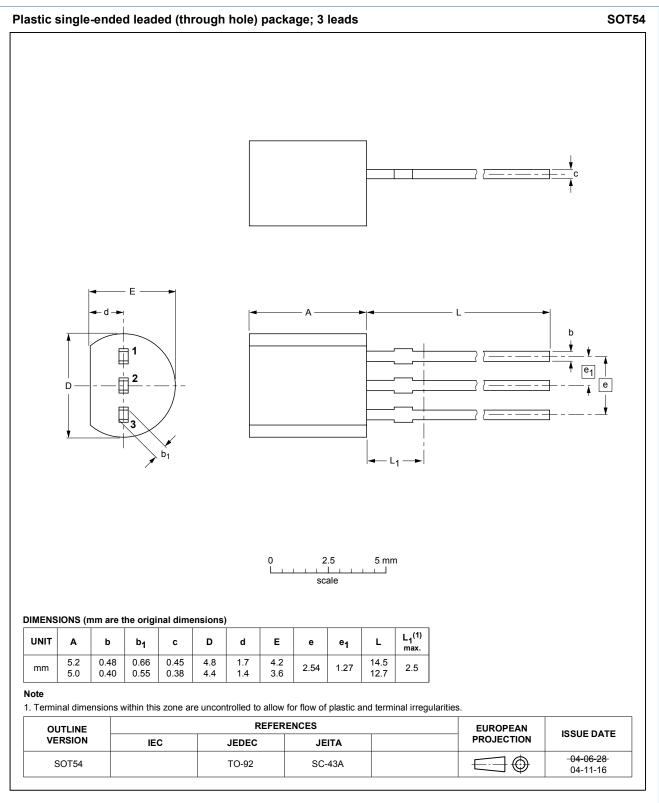


Fig. 13. Package outline TO-92 (SOT54) Z0109MA0 All information provided in this document is subject to legal disclaimers.
