

Note 1: Ensure that the junction temperature does not exceed 150  $^{\circ}$ C.






Fig. 7.1 Marking




Fig. 8.1 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.3 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.5 V<sub>CE(sat)</sub> - T<sub>c</sub>




Fig. 8.2 I<sub>C</sub> - V<sub>CE</sub>




Fig. 8.4 I<sub>C</sub> - V<sub>GE</sub>




Fig. 8.6 V<sub>CE</sub>, V<sub>GE</sub> - Q<sub>g</sub>




Fig. 8.7 C - V<sub>CE</sub>




Fig. 8.9 Switching Time - I<sub>C</sub>




Fig. 8.11 Reverse Bias SOA (Guaranteed Maximum)




Fig. 8.8 Switching Time - R<sub>G</sub>




Fig. 8.10 Safe Operating Area (Guaranteed Maximum)





Fig. 8.12  $r_{th(j-c)} - t_w$  (Guaranteed Maximum)
