





Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)









Fig. 8.5 R_{DS(ON)} - I_D












Fig. 8.8 Capacitance - VDS






Fig. 8.10 Dynamic Input/Output Characteristics




