1. Functional Description

Quad 2-Input OR Gate

2. General

The 74HC32D is a high speed CMOS 2-INPUT OR GATE fabricated with silicon gate C²MOS technology. It achieves the high speed operation similar to equivalent LSTTL while maintaining the CMOS low power dissipation.

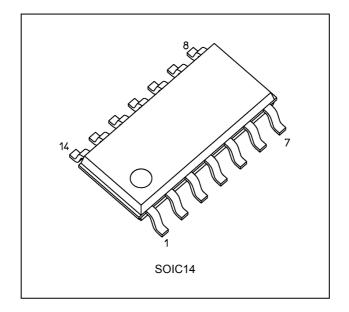
The internal circuit is composed of 2 stages including buffer output, which provide high noise immunity and stable output.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.


- (1) High speed: t_{pd} = 6 ns (typ.) at V_{CC} = 5 V
- (2) Low power dissipation: $I_{CC} = 1.0 \ \mu A \ (max)$ at $T_a = 25 \ ^{\circ}C$
- (3) Balanced propagation delays: $t_{PLH} \approx t_{PHL}$
- (4) Wide operating voltage range: $V_{CC(opr)} = 2.0$ to 6.0 V






