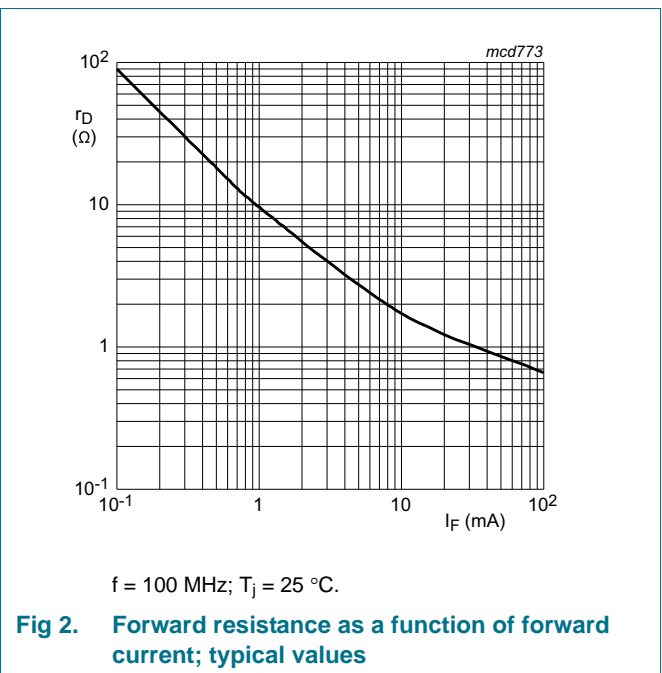

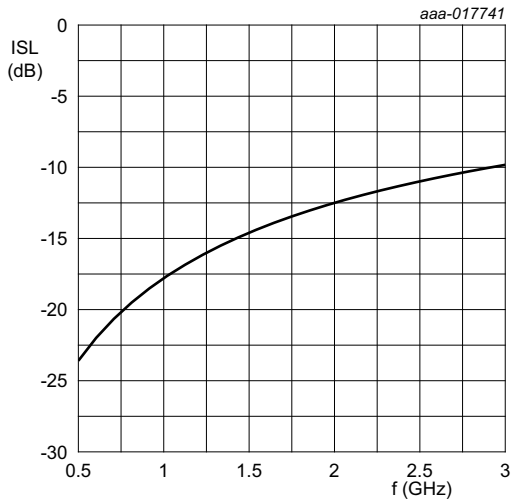

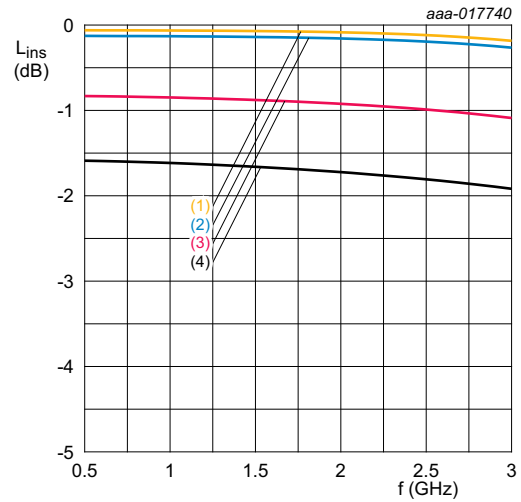

**Fig 3. Isolation of the diode as a function of frequency; typical values**



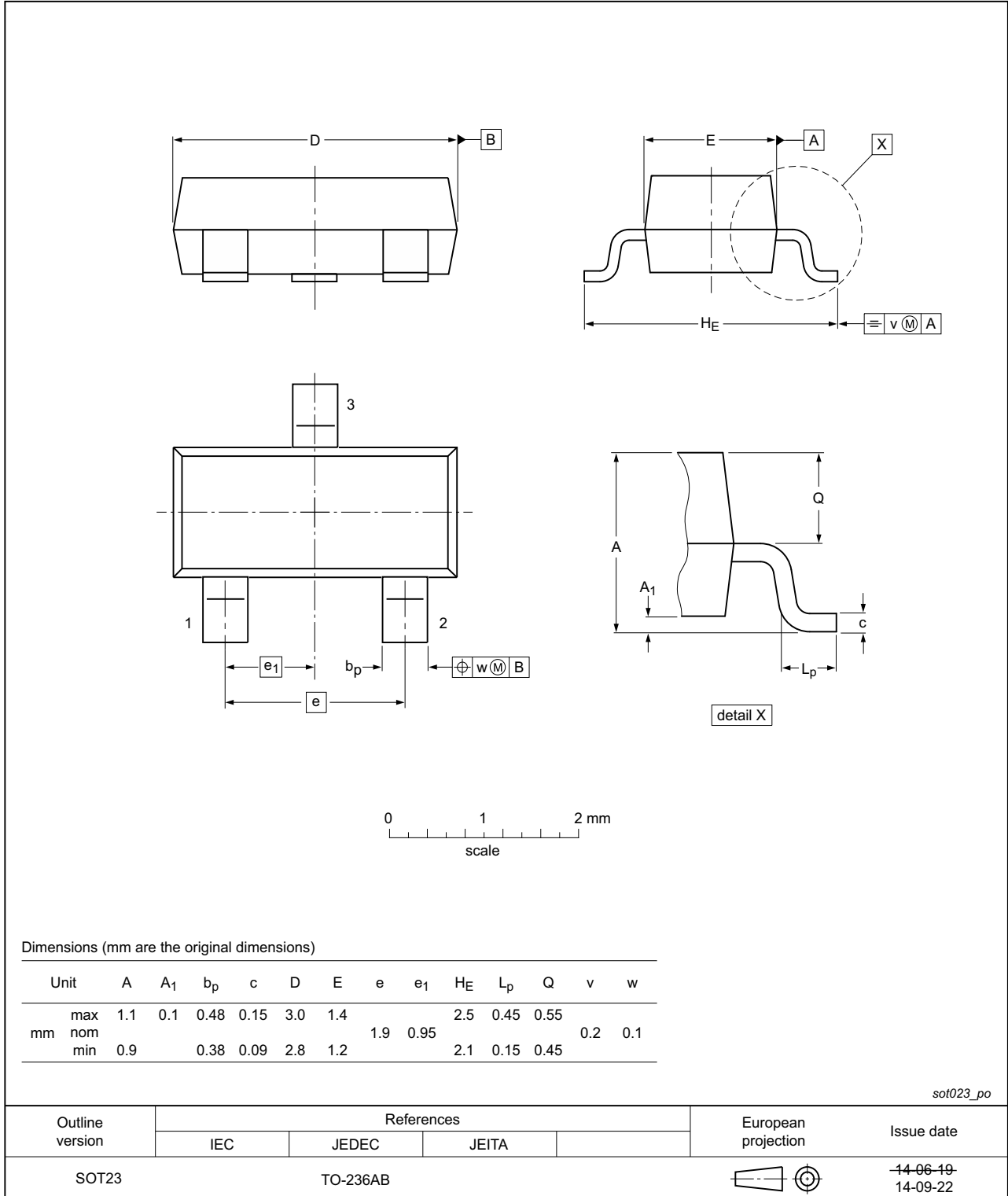
$T_{amb} = 25\text{ }^{\circ}\text{C}$
