

### **Switching Time Test Circuit**



Vth can be expressed as voltage between gate and source when the low operating current value is ID = 1 mA for this product. For normal switching operation, V<sub>GS (on)</sub> requires a higher voltage than V<sub>th</sub> and V<sub>GS (off)</sub> requires a lower voltage than V<sub>th</sub>.

(The relationship can be established as follows:  $V_{GS (off)} < V_{th} < V_{GS (on)}$ ) Be sure to take this into consideration when using the device.

#### **Handling Precaution**


