# 74VHC08FT

## 1. Functional Description

• Quad 2-Input AND Gate

### 2. General

The 74VHC08FT is an advanced high speed CMOS 2-INPUT AND GATE fabricated with silicon gate  $C^2MOS$  technology.

It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.


The internal circuit is composed of 4 stages including buffer output, which provide high noise immunity and stable output.

An input protection circuit ensures that 0 to 5.5 V can be applied to the input pins without regard to the supply voltage. This device can be used to interface 5 V to 3 V systems and two supply systems such as battery back up. This circuit prevents device destruction due to mismatched supply and input voltages.

- (6) Power down protection is provided on all inputs.
- (7) Balanced propagation delays:  $t_{PLH} \approx t_{PHL}$
- (8) Wide operating voltage range:  $V_{CC(opr)} = 2.0 \text{ V to } 5.5 \text{ V}$
- (9) Low noise:  $V_{OLP} = 0.8 V (max)$
- (10) Pin and function compatible with the 74 series (AC/HC/AHC/LV etc.) 08 type.








