2. General

The Toshiba TLP2161 consists of a high-output GaA ℓ As light-emitting diode coupled with a high-speed photodiode-transistor chip. It is housed in the SO8 package. It has two circuits built into a single SO8 package, which can reduce the mounting area.

This photocoupler guarantees operation at up to 125 °C and on supplies from 2.7 V to 5.5 V. Since TLP2161 has guaranteed 2 mA low supply current (I_{CCL}/I_{CCH}), and 1.6 mA ($T_a = 125$ °C) low threshold input current(I_{FHL}), it contributes to energy saving of devices. It can drive directly from a microcomputer for a low input current.

The TLP2161 has an internal Faraday shield that provides a guaranteed common-mode transient immunity of $\pm 20~kV/\mu s.$








Fig. 12.1.1 V_{OL} Test Circuit




Fig. 12.1.3 I_{CCL} Test Circuit




Fig. 12.1.2 V_{OH} Test Circuit





Fig. 12.1.4 I_{CCH} Test Circuit







Fig. 12.1.6 Common-Mode Transient Immunity Test Circuit and Waveform

13. Soldering and Storage

13.1. Precautions for Soldering

The soldering temperature should be controlled as closely as possible to the conditions shown below, irrespective of whether a soldering iron or a reflow soldering method is used.


• When using soldering reflow.

The soldering temperature profile is based on the package surface temperature.

Reflow soldering must be performed once or twice.

The mounting should be completed with the interval from the first to the last mountings being 2 weeks.

• When using soldering flow

Preheat the device at a temperature of 150 $^{\circ}$ C (package surface temperature) for 60 to 120 seconds. Mounting condition of 260 $^{\circ}$ C within 10 seconds is recommended.




13.2. Precautions for General Storage

- Avoid storage locations where devices may be exposed to moisture or direct sunlight.
- Follow the precautions printed on the packing label of the device for transportation and storage.
- Keep the storage location temperature and humidity within a range of 5 °C to 35 °C and 45 % to 75 %, respectively.
- Do not store the products in locations with poisonous gases (especially corrosive gases) or in dusty conditions.
- Store the products in locations with minimal temperature fluctuations. Rapid temperature changes during storage can cause condensation, resulting in lead oxidation or corrosion, which will deteriorate the solderability of the leads.
- When restoring devices after removal from their packing, use anti-static containers.
- Do not allow loads to be applied directly to devices while they are in storage.
- If devices have been stored for more than two years under normal storage conditions, it is recommended that you check the leads for ease of soldering prior to use.







Fig. 16.3 Marking on Packing








Fig. 17.3.1.1 Device Orientation
