# **General Description**

The LCXR2245 contains eight non-inverting bidirectional buffers with 3-STATE outputs and is intended for bus oriented applications. The device is designed for low voltage (2.5V and 3.3V) V<sub>CC</sub> applications with capability of interfacing to a 5V signal environment. The T/R input determines the direction of data flow through the device. The  $\overline{\text{OE}}$  input disables both the A and B ports by placing them in a high impedance state. The 26 $\Omega$  series resistor helps reduce output overshoot and undershoot.

The LCXR2245 is fabricated with an advanced CMOS technology to achieve high speed operation while maintaining CMOS low power dissipation.













#### Figure 3. 20-Lead Small Outline Integrated Circuit (SOIC), JEDEC MS-013, 0.300" Wide




#### Figure 5. 20-Lead Shrink Small Outline Package (SSOP), JEDEC MO-150, 5.3mm Wide
