




Figure 1. Block Diagram




Figure 2. 5V Electronic Shutdown Regulator

D1 protects the device during an input short circuit.




Figure 3. Slow Turn-On Regulator




Figure 4. Current Regulator




Figure 6. 3-Lead, TO-92, Molded, 0.200 in Line Spacing Lead Form
