





Figure 1. Dark Current vs. Ambient Temperature

Figure 2. Dark Current vs. Collector Emitter Voltage






Figure 3. Light Current vs. Collector to Emitter Voltage Figure 4. Light Current vs. Collector - Emitter Voltage
