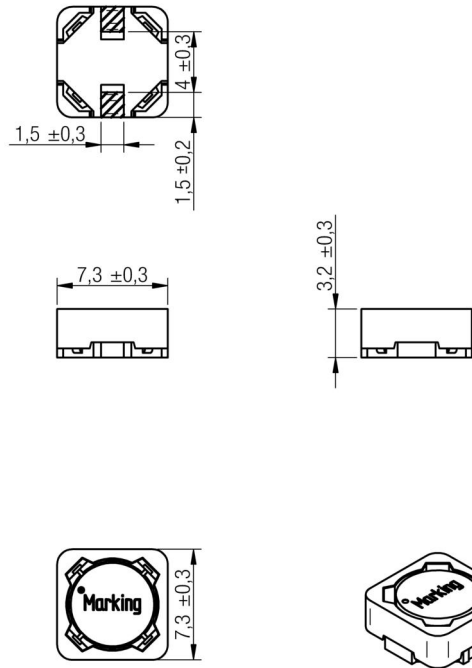

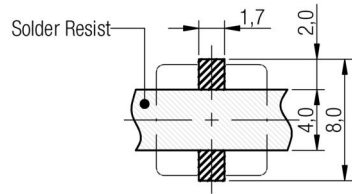

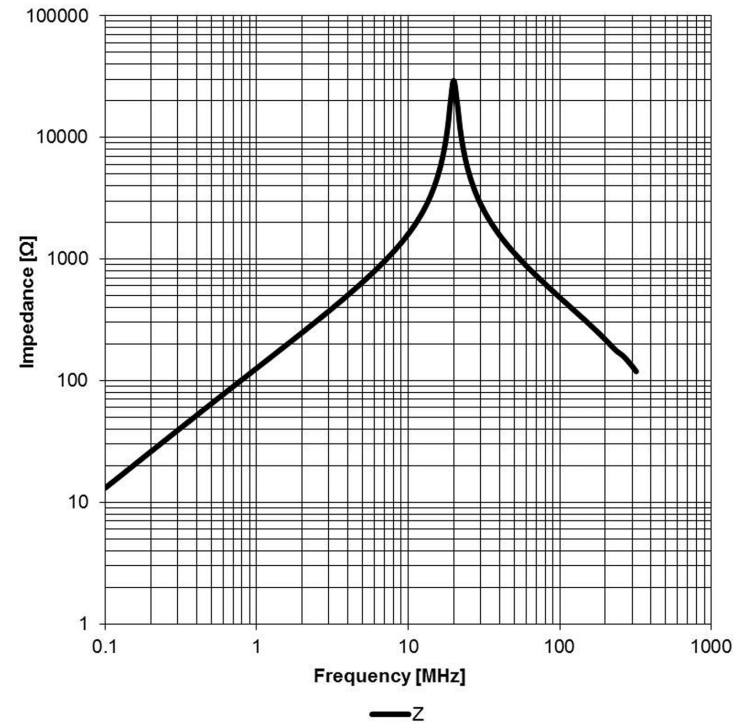

**F1 Typical Inductance vs. Current Characteristics:**



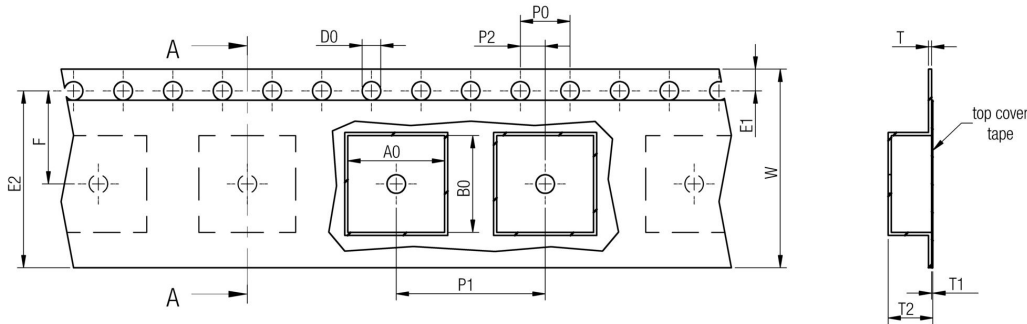
**F2 Typical Impedance Characteristics:**



### Product specific:


